The items listed below are those that the provider was not in compliance with at the time of the inspection.

Compliance Plan Action #1

Administrative Rule:

67:42:17:25

All equipment, utensils, kitchenware, dining tables, and food contact surfaces of equipment must be washed, rinsed, and sanitized after each meal. Toys capable of being placed in a child's mouth must be cleaned and sanitized daily, using a solution approved by the department. All providers, program employees, and children shall wash their hands with soap, before preparing food or beverages, eating, handling food, or feeding a child, and after changing a diaper, using the toilet, helping a child use a toilet, or coming into contact with bodily fluid.

Summary of Non-Compliance Finding:

Cleaner used on mouthable toys contains a fragrance and should not be used on food contact surfaces or mouthable toys. Cloth towels used by multiple children were in use at the handsinks.

Corrections to be Made:

Cleaning and sanitizing solutions used must be approved by the department. Towels used for drying hands after handwashing must be single use towels. The expected completion date for both is 05/06/25.

Corrections Made:

Verification was received that an approved sanitizing solution is being used and single use towels are available at the handsinks.

Compliance Plan Action #2

Administrative Rule:

67:42:17:44

All toxic or hazardous substances must be:

- (1) Inaccessible to children;
- (2) Used according to manufacturer's instructions;
- (3) Stored in the original or other labeled container; and
- (4) Disposed of according to manufacturer recommendations.

Bio-contaminants must be handled and disposed of properly. Soiled diapers must be changed promptly, in a designated area, on a non-porous surface. The diaper changing area must be clean and disinfected with a sanitizing solution approved by the department. Soiled diapers must be kept in a leakproof, nonabsorbent container that is covered with a

tight-fitting lid.

Summary of Non-Compliance Finding:

Spray paint and other paint cans were in a location accessible to children.

Corrections to be Made:

Hazardous substances must be located inaccessible to children. The expected completion date is 05/06/25.

Corrections Made:

Verification was received that a lock on the cabinet was repaired to assure items stored inside are inaccessible.

Compliance Plan Action #3

Administrative Rule:

67:42:17:32

All walls, ceilings, floors, and equipment must be easily cleanable, kept clean, and in good repair. Heating and cooling systems must maintain a temperature between sixty-five degrees Fahrenheit and seventy-five degrees Fahrenheit. For a child care center and school-age program, all heating and cooling systems must be inspected annually, by a certified technician.

Food preparation areas, including tables and countertops, must be made of a smooth, nonporous material, kept clean and sanitized, be free of cracks, and be in good repair. Center and school-age programs, in which more than twenty children are cared for, must provide a ventilation hood over all cooking areas. The hood must be appropriate for the type of appliance and intended use, as required in § 61:15:01:01.

Summary of Non-Compliance Finding:

The inside of the microwave needed to be cleaned.

Corrections to be Made:

Food preparation areas must be kept clean. The expected completion date is 05/06/25.

Corrections Made:

Verification was received that the microwave was cleaned.

Compliance Plan Action #4

Administrative Rule:

67:42:17:38

The following must be inaccessible to a child:

- (1) Firearms;
- (2) Pellet guns, BB guns, and cap guns;
- (3) Matches and lighters;
- (4) Tobacco products;
- (5) Choking and strangulation hazards;
- (6) Items capable of being pulled or tipped onto a child;
- (7) A platform measuring more than thirty inches above ground level, unless surrounded by a railing that is at least

thirty-six inches tall with no more than five inches between openings; and

(8) Other hazardous condition as identified by the department.

The department may direct a provider to remove or correct a hazardous condition or circumstance not covered in this chapter, if the department considers the conditions or circumstances to have the potential to cause injury or illness to the children in care.

Summary of Non-Compliance Finding:

The children of an employee were in the kitchen while the employee was preparing lunch.

Corrections to be Made:

The kitchen must be inaccessible to children during food preparation. The expected completion date is 05/06/25.

Corrections Made:

Verification was received that the issue was corrected by assuring that children will not be allowed in the kitchen during food preparation.
