### Compliance Plan Action #1

**Administrative Rule:**

67:42:17:29

A provider shall have a written care plan for each child who has a known food allergy. The plan must contain instructions regarding any food allergens, steps to be taken to avoid that food, and a detailed treatment plan to be implemented if the child has an allergic reaction.

**Summary of Non-Compliance Finding:**

During a complaint investigation conducted by the Office of Licensing & Accreditation, it was determined that a child with a known food allergy was served food with ingredients they were allergic to.

**Corrections to be Made:**

The program will obtain additional allergic reaction training.

**Corrections Made:**

The program required all staff to complete additional training on allergic reactions, including the use of EpiPens and recognizing the signs of anaphylaxis. Anaphylaxis information posters have been placed in each room throughout the building. Additionally, because the allergen was introduced through a food item brought in for a child's birthday, the program has implemented a new policy prohibiting outside food for birthday celebrations.

### Compliance Plan Action #2

**Administrative Rule:**

67:42:17:20

A center provider supervising children must be in the same room with the children or on the playground with the children, and must be able to see or hear the children, at all times.

If children are in a school-age program, the provider must be able to hear or see the children, at all times, and must be close enough to intervene at all times.

**Summary of Non-Compliance Finding:**

During a complaint investigation conducted by the Office of Licensing & Accreditation, it was determined that a provider left children unsupervised on the playground after discovering that some school-age children were playing in the parking lot.

**Corrections to be Made:**

The program will ensure that children are supervised at all times and no children will be left alone.

**Corrections Made:**

The providers have a clear understanding of the supervision requirements. The program closed their license on 8/1/25.
