Compliance Plan Action #1

Administrative Rule:

67:42:17:20

A center provider supervising children must be in the same room with the children or on the playground with the children, and must be able to see or hear the children, at all times.

If children are in a school-age program, the provider must be able to hear or see the children, at all times, and must be close enough to intervene at all times.

Summary of Non-Compliance Finding:

During a complaint investigation conducted by the Office of Licensing & Accreditation on June 6, 2025, it was found that three children left the playground area and walked to a nearby road without the provider being aware.

Corrections to be Made:

Staff must supervise children at all times within the center and outside on the playground.

Corrections Made:

The program submitted a detailed, written plan addressing how the issue will be corrected, which has been approved by the Office of Licensing & Accreditation.

Compliance Plan Action #2

Administrative Rule:

67:42:17:21

A center or school-age program must maintain the following ratios:

- (1) Five children to one staff for children up to three years of age;
- (2) Ten children to one staff for children three through four years; and
- (3) Fifteen children to one staff for children five years and over.

Children of program employees must be included in determining the children to staff ratio.

Summary of Non-Compliance Finding:

During a complaint investigation conducted by the Office of Licensing & Accreditation on June 6, 2025, it was determined that the staff-child ratio was not maintained when three children left the playground area. One provider went inside the building leaving another provider alone with ten children; two providers were required to maintain ratio.

Corrections to be Made:

The program must maintain the required staff to child ratios, based on age, at all times.

Corrections Made:

The provider submitted a detailed plan addressing how staff-child ratios will be maintained at all times.
