- (5) The names of individuals authorized to pick up the child;
- (6) Health information, including any allergies or special needs;
- (7) A current immunization record or, for a school-age program, the name of the child's school;
- (8) Parental permission for medication;

- (9) The child's attendance records;
- (10) The date of the child's enrollment; and
- (11) The date on which the child's enrollment ends.

The provider shall annually review and update each record required under this section, and make the child's record available to the department, upon request.

Summary of Non-Compliance Finding:

There was one child record that was missing an emergency contact name and telephone number.

Corrections to be Made:

All child records shall be maintained with the required information outlined in ARSD 67:42:17:42.

Corrections Made:

The child record was updated to include all the required information outlined in ARSD 67:42:17:42.
