Corrective Action Plan #1

Administrative Rule:

67:42:17:46

A provider shall complete pediatric first aid training every five years and maintain documentation of the training. A provider must be certified in pediatric cardiopulmonary resuscitation. The certification must include a hands-on skills test.

A provider shall work under supervision until the provider has completed the training required by this section. The supervisor shall have completed their pediatric first aid training and be certified in pediatric cardiopulmonary resuscitation.

Summary of Non-Compliance Finding:

During a Family Day Care inspection conducted by the Office of Licensing and Accreditation (OLA) on March 11, 2026, it was determined that the provider did not have current Pediatric CPR certification as required. To this date, the provider has not submitted verification demonstrating completion of the required pediatric CPR certification.

Corrective Action:

Documentation

verifying completion of required pediatric CPR certification must be obtained.

Supporting Evidence:

To verify completion of the pediatric CPR certification, documentation demonstrating completion of the pediatric CPR certification must be submitted to OLA by July 17, 2026.

How Maintained:

The provider will ensure that current Pediatric CPR certification is maintained at all times by renewing the certification before its expiration date. The provider is responsible for monitoring certification expiration dates, scheduling renewal training sufficiently in advance to prevent any lapse in certification, and maintaining documentation verifying current certification for review by OLA upon request.

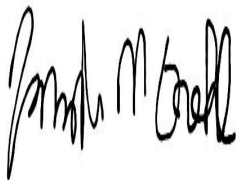
