67:42:17:42

- (4) Parental permission for emergency medical treatment;
- (5) The names of individuals authorized to pick up the child;
- (6) Health information, including any allergies or special needs;
- (7) A current immunization record or, for a school-age program, the name of the child's school;
- (8) Parental permission for medication;
- (9) The child's attendance records;
- (10) The date of the child's enrollment; and
- (11) The date on which the child's enrollment ends.

The provider shall annually review and update each record required under this section, and make the child's record available to the department, upon request.

Summary of Non-Compliance Finding:

Two child records were missing current immunization records.

One child record was missing emergency contact/phone#, emergency medical care permission and authorization for child pick up.

Corrections to be Made:

Provide current immunization records for the two child records missing them.

Provide documentation of emergency contact/phone#, emergency medical care permission and authorization for child pick up for the child record missing it.

Corrections Made:

Documentation of emergency contact/phone number, emergency medical care permission and authorization for child

pick up is on file at the daycare for the child record missing it.

Documentation of compliance with immunization requirements was received for two child records.
