Compliance Plan Action #2

Administrative Rule:

67:42:17:09

The program administrator is the director or individual responsible for planning and implementing the program in a licensed child care or school-age program and must be at least eighteen years of age and:

- (1) Have a bachelor's degree in a field of education or human development;
- (2) Have a two-year degree in early childhood education;
- (3) Have a Child Development Associate credential or comparable credential, as determined by the department;
- (4) Hold certification in a child learning philosophy and have at least one year of experience in a child care setting;
- (5) Have a child development technician diploma; or
- (6) Have four years of experience in a center or school-age program.

Summary of Non-Compliance Finding:

The program does not currently have a program administrator who meets qualifications.

Corrections to be Made:

The program must have a qualified program administrator.

Corrections Made:

The site is no longer operational for 2026 and will ensure there is a qualified program administrator in 2027.

Compliance Plan Action #3**Administrative Rule:**

67:42:17:15

A child care provider shall maintain a record for each employee that includes:

- (1) The employee's name and date of birth;
- (2) The dates on which the employee began and ended employment;
- (3) Documentation of orientation and ongoing annual training, if the employee provides direct care and supervision of children;
- (4) A statement that:
 - (a) Defines child abuse and neglect;
 - (b) Sets forth the employee's responsibility to report all incidents of child abuse or neglect in accordance with SDCL 26-8A-3 and 26-8A-8; and
 - (c) Is signed by the employee; and
- (5) The results of the background check.

All records required by this section must be reviewed and updated at least annually by the provider, made available to the department for verification of the contents, and retained by the provider for six months after the employee leaves the program.

Summary of Non-Compliance Finding:

Information was incomplete for 12 provider files including a date of birth for three providers, an employment start date for three providers, background check results for one provider, verification of completed orientation training for 10 providers, verification of current CPR certification for 12 providers, and verification of annual training for five providers.

Corrections to be Made:

Although the program operates temporarily at this site during the summer, the providers are also employed at other Boys & Girls Club locations. Required information must be obtained for providers who remain employed at other licensed sites. Four providers are no longer employed by the program.
